The EIF-NPI Equity Platform is an initiative of the European Investment Fund (EIF) to promote knowledge sharing and best practices between EIF and national promotional institutions (NPIs) across EU Member States. The EIF-NPI Equity Platform is governed by [its charter](#) (the Charter). Capitalised terms not otherwise defined herein shall have the meaning given to them in the Charter.

The EIF-NPI Equity Platform is constituted by a General Forum, a Consultative Forum and a Secretariat. The operation of the General Forum is further governed by the General Forum Rules of Procedure.

To be eligible for membership in the EIF-NPI Equity Platform's General Forum, applicants must be an NPI in accordance with the NPI Definition set out herebelow.

As contemplated in Article 2(3) of Regulation (EU) 2015/1017 of the European Parliament and of the Council of 25 June 2015 which relates *inter alia* to the European Fund for Strategic Investments, NPIs are defined as **legal entities carrying out financial activities on a professional basis which are given a mandate by an EU Member State or an EU Member State's entity at central, regional or local level, to carry out development or promotional activities** (the NPI Definition).
