18/106 Avia Capital 1 - addendum

Polish Growth Fund of Funds, EIB-EIF SME Funds Investment Facility, Risk Capital Resources, own resources

Generalist private equity fund focusing on lower mid-market investments in Poland.

The Board of Directors approved an addendum to the fund structure and resource allocation for an investment in Avia Capital 1, on the terms and conditions set out in document 18/106.
