The CHAIR advised that, in light of Mr. POLÓNYI’s resignation as member from both the EIB’s and the EIF’s Boards of Directors on 26 July 2024, in conjunction with leaving his position at the Slovak Ministry of Finance, Mr. DOWGIELEWICZ was acting as full member, pending the EIB’s designation of Mr. POLÓNYI’s successor.

The CHAIR also took the opportunity to inform the Board of the forthcoming departure of the Chief Investment Officer (“CIO”), Alessandro TAPPI. She thanked him, also on behalf of the Board of Directors, for his excellent work and outstanding contribution to the EIF. The CHAIR congratulated Marco MARRONE, the Deputy CIO, on his appointment as the incoming CIO.

The CHIEF EXECUTIVE underlined the important role that Alessandro TAPPI had played across the Fund’s lifetime, having joined the EIF in 1995, and gave words of welcome to Marco MARRONE in anticipation of his new role.
