- 47 applications
 - 44 for the direct guarantee
 - 3 applications for the counter-guarantee
- 39 (counter-) guarantee contracts signed (including 4 increases) (1)
- covering 17 countries (2)
 - for a total (counter-) guarantee amount of EUR 1,129.6m
- Expecting to provide over EUR 2,331.3m of financing to SMEs
- Currently enabling the support of 4,146 SMEs and 244,290 jobs (at 1st inclusion)






