



- 163 guarantee contracts signed*
 - covering 31 countries**
 - for a total guarantee amount of EUR 408.2M
- Expecting to provide over EUR 2,855.8M of financing to micro-enterprises
- Expecting to provide over EUR 1,440.0M of financing to social enterprises
- Currently enabling the support of
 - 166,605 micro-enterprises and
 - 7,019 of social enterprises




EaSI GFI Portfolio - by Country


