Status of WB GF4SME implementation as of 30/06/2025

- 18 guarantee contracts signed (1)
 - covering 6 countries (2)
 - for a total guarantee amount of EUR 60.0M (3)
- Expecting to provide over EUR 886.6M of financing to SMEs
- Currently enabling the support of 7,368 Final Recipients and 74,886 jobs at first inclusion



Graph 1. Countries targeted with guarantee contracts signed



Amount Disbursed to Final Recipients by Country





(amounts disbursed to Final Recipients in M of EUR)


